**LATE PAYMENTS**

A material precondition to the above-named student being permitted to attend classes at the School is that all payments be current. Should any installment remain unpaid thirty (30) days after the due date, the School, at its option, may require the withdrawal of the student and any and all tuition assistance granted will be forfeited. Such withdrawal shall not relieve the undersigned of the obligation to pay the full tuition due for the entire 2011-2012 academic year. Any forbearance of the School in exercising any right it may have under the Enrollment Contract shall not be a waiver of, or preclude, the future exercise of any right or remedy available to the School under this Enrollment Contract. The undersigned parent(s) or guardian(s) hereby agree to pay all costs and attorney's fees incurred by the School in the enforcement of this Enrollment Contract. Payments more than thirty (30) days past due are subject to a late payment fee of one and one-half percent (1 ½%) per month.

**ACCEPTANCE OF EDUCATION PROGRAMS**

- 1) The school in accepting this enrollment contract agrees to deliver to the best of its ability a quality education meeting state and federal guidelines wherever possible. The undersigned hereby agrees to accept the School's education programs and the rules and regulations outlined in the Student/Parent Handbook, together with any modifications deemed appropriate, in the School's sole judgment. In the event the administration determines that it is not in the best interests of the student, fellow students, or the School for the student to continue, the administration may suspend the student or require the student's withdrawal or dismissal. The decision of the administration shall be final; any such decision shall not relieve the undersigned of the obligation to pay the full tuition for the entire 2011-2012 academic year.
- 2) I agree that the student named above may take part in all School sports and activities and may take any School-sponsored trip; and the School may use my child's photograph in various school newsletters, website, and admissions ads and brochures, and may use my child's name and photograph in press releases announcing honor roll, or other activities or honors of distinction, unless I give written notice to restrict such activities and usage.
